Roaring Creek Ride & Meeting

A good time was had by all those who attended the Louisiana Chapter trail ride, meeting, greeting, and eating at the Roaring Creek Camp near Forest Hills. The weather was great, the dogwoods were blooming, the riding was wonderful, the food was delicious, and the fellowship was fine. After the ride on Saturday morning, a business meeting was held. Following is a summary of that meeting.

First of all, it was unanimously agreed that we would continue to have and support the Louisiana Chapter, and would continue to be an affiliate of the Missouri Fox Trotting Horse Breed Association in Ava, Missouri. To remain an affiliate chapter, we have to have at least twenty members who are also current members of the MFTHBA. No nominations for any of the club offices had been received, so it was agreed that the current officers would continue. The list of officers is shown below. The dues will continue to remain at \$10.00 for a single membership and \$20.00 for a family membership. The club will continue to sponsor, at a minimum, a spring trail ride and the Nick Cox Trail Ride at Chemin-A-Haut State Park in September. If any of our members wish to sponsor another trail ride, the Club will assist with the finances. It was also agreed that our club would continue to financially support the Southern Classic Horse Show as in the past. We have been contributing \$400.00 toward that show for the past several years.

The club's finances were discussed. We have a checking account balance of approximately \$2685.00 and a CD valued at approximately \$3140.00. Also, the club still owns a small cargo trailer with some trail obstacle equipment.

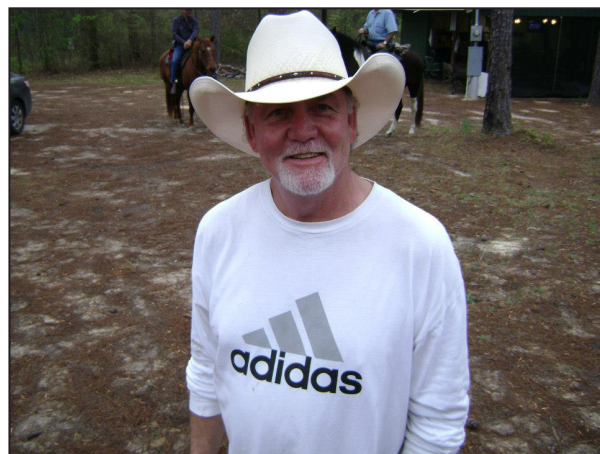
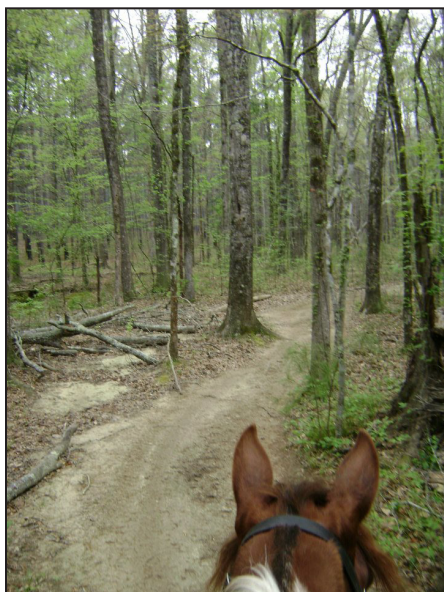
